RULES FOR ENTRY

1. Must be 18 years or older. All submissions must be family friendly.
2. Artists must register and get their surfaces stamped. A flat entry fee to be paid when registering. No limit to number of surfaces to be stamped but each artist is limited to three submissions for the exhibit.
3. All work should be completed en plein air. No studio or work from photos.
4. Painting locations may be anywhere south of Trenton.
5. Entries must include the location in the title. Each entry must be signed by the artist.
6. All works submitted must be dry, framed, and properly wired. (no sawtooth hangers)
7. Depending on number of entries received (Due to space constraint) all entries may not be included in the exhibit. However each registered artist is guaranteed to have at least one work included in the exhibit.
8. Sales are encouraged. MAC receives a 30% commission and collects sales tax on all sales.
