What may be entered - All media. Must be family friendly. Work should be original (no reproductions), conceived by & signed by the artist.  
3 entries per artist Work can not have been previously shown at the MAC.

## ENTRY INFORMATION:

1. This is a juried exhibit. Not all work will be accepted or hung.
2. All work should be properly framed and wired. NO SAW TOOTH HANGERS. Plexiglass must be used if any dimension exceeds 30 inches
3. Artwork may not exceed 48 inches in any direction including frame.
4. Each submission should be labeled with title, artist name, medium, price.
5. Sales are encouraged. MAC receives a 30% commission and collects sales tax on all gallery sales.
6. NO work, including sold work, may be removed prior to the exhibit's end.

**Liabilities:** Art work will be handled with all possible care; however, the Medford Arts Center will not be held responsible for loss or damage from any cause whatsoever. Submission of art to the MAC implies an agreement on the part of the artist with this condition.
